Robbie L brought a report from Region. Region has increased prudent reserves a large amount to allow for billboards across the region and asked that all areas vote on whether to suspend the 3% donation to the Southern Zone in order to help with this budget increase. GSR's will take this to the homegroups and get a vote. ASC requested that Robbie bring to Region the question of why areas were not asked to vote on the prudent reserve increase as it is over the \$500 limit that is allowed without doing so. Trevis requested the remaining \$20 in the literature budget to order medallions. Doug confirmed with ASC that all were in agreement with the "mandatory masks" signs in the building. The couches were voted on by homegroups and 3 groups were for getting rid of them, 1 group wanted to get new couches and 1 group abstained. This suggestion will be brought to the River City board.

#### **New Business:**

Pam has resigned from secretary position. This opening should be mentioned to homegroups. Robbie L brought motion to make a phone list for newcomers or to add the words "phone numbers" on the back of the meeting lists. ASC decided this was not an area matter, but could be done on a homegroup or individual level. Dustin brought motion for a new subcommittee for cleaning the clubhouse. This was passed and will now go to homegroups. Robbie L brought a motion to set up IP's in treatment centers and post flyers with information on how to obtain literature. Motion did not pass, but the subcommittee will meet to discuss making literature available to facilities.




