## Activities report

Hello family. Our last activity was the Mardi Gras function on February 19, 2022 at the clubhouse. It went well. I have attached the receipts for drinks etc., decorations, and king cakes. I had gotten a $\$ 400$ check but could not cash it as it got wet and I had to rip it up. The decorations were $\$ 76.90$, the 3 king cakes were $\$ 123.06$, and the Walmart items equaled $\$ 51.31$. Total spent was $\$ 251.27$. I am asking reimbursement in this amount.

The next event we are planning is a crawfish boil on Saturday, May 14, 2022. Last year's boil went well, but there are a few things I learned from this event. I am trying to get a spot with more parking this year at Buhlow Lake. If that is not possible, we will need volunteers to monitor parking. We will sell tickets prior to the event to get a better idea of how many pounds to buy and also to get money together to get enough crawfish. We will need volunteers to help sell tickets, set up, boil crawfish (not the same volunteers as last year, as they did not end up helping much at all), help manage event (such as controlling music, doing auction, selling 50/50 raffle tickets, etc.), and to clean up. We will also need 2 speakers, either local or otherwise, and some auction items. This event will take a lot of work so any volunteers will be greatly appreciated. By next area, I hope to have all of the details ironed out.

After that, we host Region in July. We will discuss this more in the next couple of months.
