Regional Delegate Report for October 12-13, 2024

Hello all,

I'm going to try and go through things in chronological order, but as always, feel free to stop me/us with

questions and comments about the issue or issues at hand.

On July 20, 2024, we had a Conference Participants Web meeting.

We had our first inklings of storm clouds on the horizon for WCNA then. Anthony, the ED for NAWS, told us that the break-even point for WCNA was 24,000 paid registrations and that they only had about 14,000 at that time. He also commented that hotel reservations were lagging behind as well.

Hotel reservations are important because as some of you know, convention planners typically make deals for reduced rates on all kinds of things based on a guarantee of a specific number of room rentals. If you don't hit that number, you owe extra money to the hotel.

How much money was at stake for WCNA in total? One way to answer that is to look at the number of paid registrations needed times the cost of registration. With 24,000 needed to break even at \$175 per registration, that means approximately 4.2 million had been spent or committed to. We'll come back to this in a bit.

We were told that the European WSO office was "temporarily" closing and that there was or would be a letter in our "dropbox" explaining this further. I never saw such a letter and can't tell you anything more about that.

We were told that reorganizing had prevented an updated financial statement.

Focus groups were scheduled for the "H&I Basics" and the "Virtual Service Basics" projects. The CAR survey creation was about to begin with the goal being recommendations for new literature and service material will come from the survey and not through motions and project plans at WSC. They seemed happy that last year's CAR survey had about 7,000 responses, although that's only about .3% of the NA membership.

They also talked about a proposal that in 2026, when conference participants indicate that 80% are in favor of something before the conference, that will then become a decision and not further discussed during the conference.

On July 26, 27, and 28, Southern Zonal Forum met in New Orleans

A PR event held on Friday evening was top quality according to those who attended, and there is a recording of the presentation available on the SZF web site if anyone wants to check that out for themselves. Our regional representation, however, was abysmal. According to the

attendance sheet, there were 4 people from the Louisiana Region in attendance. It wasn't any better on Saturday, when the SZF did two workshops on topics specifically chosen by the RSC.

Then too I saw no more than 5 people from the Louisiana Region. The easy out is to blame apathy, timing, location, or any of a whole slew of other problems here in Louisiana. I don't think that's the root problem though. I think the root problem is that these presentations and workshops were not really asked for by us. We were essentially told, "We've brought things for you. Where do you want them?" It wasn't us asking them for assistance. It was them telling us they were coming, that they wanted to do something, supposedly for us, and we had to then make a forced choice on what they would do. I think this is the wrong model for SZF to follow and that instead they should let the member regions know what they can do to help in specific areas and then respond when a member region actually asks for help.

In any case, thankfully there were a good number of SZF folks there Friday evening and as I said,

the content of what was presented was actually quite good.

Weekend business:

Arkansas Region is discussing 1 v 2-day meetings for themselves; Looking at insurance for the Region; Still working on getting literature into the jails; and getting ready to host the next SZF meeting in October.

Lone Star reported that they discovered a sizable amount of money had been embezzled from their service office by trusted servants. There is a police investigation/prosecution underway; They have decided to go back to a 2-day format for RSC meetings.

Show Me Region is using zoom at RSC meetings but having technical problems; They are considering doing RSC meetings virtually only; Trying CBDM at RSC; They were incorporated but

failed to submit required filings on time and ended up being dissolved! They are getting ready to do SMCRNA (10/27?)

Tejas Bluebonnet Region says all areas are using CBDM now; South Padre area has dissolved due to lack of people to do service; AD resigned saying overwhelmed; Regional convention in Houston Feb 14-16; Doing August RSC virtually; Disruptive behavior at RSC... Treasurer and RD

got into physical/near-physical confrontation at RSC?

Treasurer absent due to family illness? Report submitted said a "full report" would be submitted soon and gave bank balance of \$14,466.64.

Sharing Session:

ZD asking for clarification of his role with US Collaboration of Zones

PR: Craig reported he had been working on event for Lone Star's upcoming RSC, but confusion over funding precluded his being able to go or to send a committee member. Asked for language in guidelines for future that says a committee is approved for funding as opposed to a particular person.

FD: Kristin reported they continue to work on Arkansas project of getting literature into the jails; Trying to get content for tablets; Presented at Lonestar RSC; Will get available workshops up on the SZF website.

Elections: Kristin was nominated for another term as FD. Craig was nominated for another term as PR. These will be voted on in October meeting.

Workgroup reports given:

Incorporation- Don't do it

Communication-

Mentorship-

Racism- Of note, this workgroup was asked to focus on the original task of establishing ways that

racism in SZF functions can and should be addressed. They also asked to be able to present a report to the US Collaboration of Zones and this request was not approved.

Open Forum:

Discussion about costs and budgets for meetings, as well as proposed budgets for PR and FD for the next year led to the establishment of a workgroup to look at this further. We don't know what has been being spent, don't know what we've had in donations! Scotty and I were both asked to be on this workgroup. We'll come back to this.

There was discussion about whether the ZD should be going to the WSC. This was tabled since the next in person WSC is not until 2026.

New Business:

Rob B nominated for Secretary. Elected

Regular inventory every 2 years. Will be in guidelines that strategic planning process will be initiated every other year in summer.

Brochure for SZF. Communication Wkgp will work on this

SZF Newsletter. Responsibility to be assigned by Steering Committee each year.

Wkgp to look at how often guidelines need to be reviewed.

Discussion about who approves budgets for PR and FD. Some want it to go back to RSCs for voting?

WCNA:

Facebook page allowed people to make ANY comments they wanted during WCNA, and they did.

Conflict and complaints about moving chairs.

Conflict with people outside the convention center presenting/selling altered or old literature. Sales pitches for NA members to commit to monthly contributions directly to WSO.

Anthony, ED of NAWS, comments while speaking on Sunday morning

September 21st CP Web meeting

NAWS: Anthony reported that the planned new website had to be brought online early, because the old site crashed.

Still no full financial report, but said "6.88 million in cash accounts," (3.5 million is income from WCNA) and "Don't think we will use all cash reserves paying bills for WCNA."

Asked about losses from WCNA, he replied, "Too early to tell... Will be a significant loss." Said while we needed 24,000 paid registrations to break even, we only had 17,160 paid

registrations... Lowest onsite registration rate ever... Don't know why numbers were down." Said they published "myth busters" to counter misinformation on social media.

Asked later about cost of venue, Anthony replied, "190,000," and said they are expecting some kind of rebate or kickback from the city on this. He also talked about expecting rebates from vendors, merchants, and properties as well as revenue from merchandise and entertainment, but all of this is up in the air.

Asked about the Non-NA material outside the convention center, Anthony said, "We threw it in

the trash can."

Asked about videos being taken and made by WSO during the convention, he said these are for NA events, not social media.

Asked about soliciting direct recurring donations from members, Jack responded "We want to be less reliant on money from literature sales."

Irene, World Board Chair, said they have surveys planned on multiple topics, input to be used in making changes in the future. Not sure how the balancing act will be accomplished of weighing input from RD's potentially representing the group conscience of thousands of members against the input of individual members through surveys.

Items for decision in the upcoming interim conference: Draft budget; Procedural issues; Require all candidates for world level service to come through RBZ process; Repurpose the World Pool; Utilize CAR survey for literature and service material; and accept straw poll consensus as decision.

Questioned about the PPP loan(s) and forgiveness of some of it, Anthony said: "We determined that forgiveness was no different from being exempt from sales tax... We did pay back the 250,000 loan because conditions it was provided in were not the same... Board decided forgiveness part was no different from tax exempt benefits... This has been written in previous reports."

SZF workgroup on budget met on zoom 10/9/24:

The gist of it is that SZF has had donations over approximately the past year of 12,812.13, and they have spent 12,743.81 on travel and lodging alone. The workgroup concluded that this spending

cannot be sustained, and is recommending that SZF budgets for the upcoming year be what was spent last year, and that SZF move to meeting only once per year in person, and twice per year virtually. If adopted, this will reduce costs for the next year by about \$6,000.

Nominations for World Board:

As we outlined at the last RSC meeting, persons wanting to serve with the World Board, WSC, or HRP, have to be nominated by a Region, Zone, or the World Board. I suspect almost everyone here knows Bob Singer.

He has been involved with pretty much every aspect of service to NA in this Region for many years. His latest completed stint was two terms on the LRCC Board and now he's serving as the chair for the next LRCNA. He has expressed his interest, and I would like have the Louisiana Region nominate him for the World Board. I presume this will come under New Business on Sunday.

Finally, I've made hotel reservations for SZF in 2 weeks in Rogers Arkansas and plan on driving there from home. The hotel costs \$272.51 and the round trip milage is 1,102 miles.
