We had an emergency vote for Ashley J. for Secretary. Passed.

Last convention in Baton Rouge only had a profit of \$8,313.14. Did not meet projected profit.

Motions:

1. Reimburse Don B. for printing policy, buying paper and envelopes to mail receipts. Total: \$67.47. Passed.
2. For Region to make a monthly commitment at Angola State Prison. Intent: providing a source of coordination between Areas to help fulfill a difficult commitment that further supports our Primary Purpose. Referred.
3. Reimburse Richard T. for payment to Facebook. Total \$299.73. Passed.
4. Policy change-change #9 in Financial Guidelines, pg.24, to A quarterly donation sent to the WSC will be determined at LRSCNA. It will consist of unencumbered funds. 10% to WSC and 3% to SZF. Intent: to practice fiscal responsibility. Referred.
5. Policy change-change donation to WSC & SZF from % of total funds to % of Area donations every quarter. Intent: Be financially responsible with Region funds. Referred to Area for vote.
6. Reimburse purchase of 25 Basic Text for jails & institutions In Region. Total: \$350.00. Intent-utilize Gumbo Cook Off Funds for stated purpose. Passed.
7. Change in Policy 23, #5 to say: Terms of Service "suggest " that all positions in Region serve no more than 2 consecutive terms in office in the same position. Intent-rotation of service. Passed.
8. Suspend all donations to WSC & SZF. Intent-to figure out

- our budget and send it to Areas to vote on. Passed.
9. Write a check to Amy G. (Chair) for \$300 for Gumbo Cook Off. Passed.
  10. On pg. 10, add lines 10 & 11 to general guidelines section. 10 should inform us that everyone can attend Saturday Sub-committee meetings virtually & 11 gives permission for sub-committee meetings to be attended virtually & Ad-hoc committees will be able to use virtual platforms to hold meetings. Intent-to inform members of availability of virtual platforms. Passed.
